- Review subcontractor method statements / risk assessments to ensure they are appropriate to the working activity. Ensure RAMS are received in advanced of works commencing on site.
- Provide leadership and support to site staff under your supervision.
- Maintain high productivity and record / report poor performance.
- Ensure suppliers and subcontractors under your supervision provide project specific ITPs/ QA check sheets before any works commence on site.

- Assist suppliers and subcontractors with the development of quality methodologies and QA check sheets.
- Ensure works are being carried to the required quality standard as detailed in the project quality plan.
- Ensure works are being carried out in line with Kier's environmental policies.
- Ensure works comply with the project specific environmental plan and waste management.
- Attend design team meetings as required.
- Ensure design team issue information in line with project programme.
- Ensure design information is reviewed and issued timeously to supply chain in line with programme.


